

Frequently Asked Questions

Q

I'm worried that the account information managed by Individual Number will be misused if Individual Number Card is lost or stolen.

\ No need to worry. /

The Individual Number Card does not record information on the accounts. Even if the card is lost or stolen, only you can use it, and the card can be temporarily suspended 24 hours a day, 365 days a year by the Individual Number general toll-free number.

Q

It means that I will be able to manage my accounts in the multiple financial institutions at once with the Individual Number, but what happens if I have not been able to update my address?

If you have not been able to update your address and your full name which you have notified to your financial institutions, it will not be recognized as your accounts and you will not be able to manage it with your Individual Number. Please update your address before applying for this system.



The Act on management of bank and savings accounts by Individual Number utilization

The System on Act on management of bank and savings accounts by Individual Number utilization

- 1 On the premise of getting the individual consent, it will be possible to number to the multiple bank and savings accounts at once via financial institutions and Mynportal.
- 2 After managing the bank and savings accounts with Individual Number, the bank and savings accounts can be identified and information on the bank and savings accounts can be provided in the event of an inheritance and disaster.

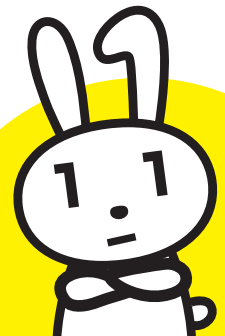

What is feasible by the Act on management of bank and savings accounts by Individual Number utilization

By the Account Management System, you will be able to manage the multiple bank and savings accounts with Individual Number at once. This application is called a "Request for Numbering Individual Number on accounts". After managing your bank and savings accounts with your Individual Number, you can identify your bank and savings accounts and receive information about your bank and savings accounts in the event of an inheritance or disaster.

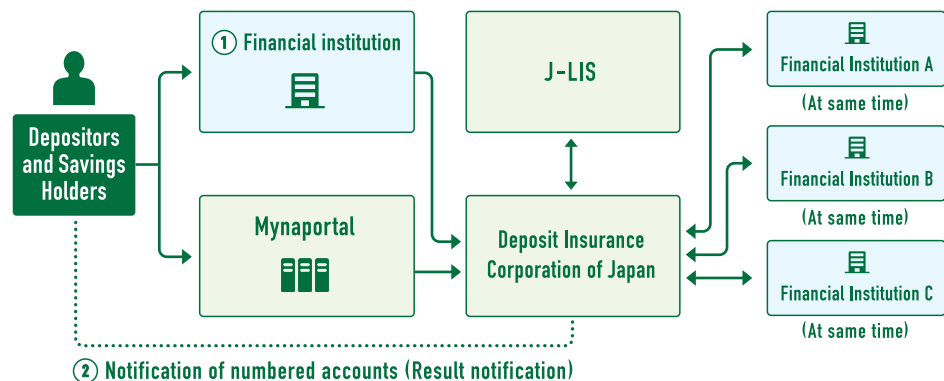

How to "Request for Numbering Individual Number on accounts"

You will be able to apply for Numbering Individual Number on accounts!

The "Request for Numbering Individual Number on accounts" allows you to apply to the multiple financial institutions at once with which you have the accounts. The image of this system is shown on the right, and the necessary information is linked via the Deposit Insurance Corporation of Japan and Japan Agency for Local Authority Information Systems (J-LIS).

What is the Deposit Insurance Corporation of Japan

It is an authorized corporation established for the primary purpose of protecting depositors. In the System on Act on management of bank and savings accounts by Individual Number utilization, it confirms that the Individual Number is correct, and links information from financial institutions to the Digital Agency.

What is the Japan Agency for Local Authority Information Systems (J-LIS)?

It is a corporation that operates the basic resident register network system. the System on Act on management of bank and savings accounts by Individual Number utilization provides the information necessary for the Deposit Insurance Corporation of Japan to confirm that the Individual Number is correct.
